Important Notice

About Repayment Forgiveness of Special Loan Funds

(Temporary Loan Emergency Funds and Comprehensive Support Funds that are Especially Granted to Address the Impact of the COVID-19 Pandemic)

1. How to apply for exemption from repayment (henceforth repayment forgiveness)

- ✓ If you (the borrower) and the head of your household are exempt from municipal tax, you are deemed to be eligible for repayment forgiveness. (Exemption from taxation for both the municipal tax per-capita rate and income tax is needed.)
- ✓ First of all, read the "Flowchart" carefully, and check whether you are eligible for repayment forgiveness or not.
- ✓ If you are eligible for repayment forgiveness, submit the necessary documents to your local Council of Social Welfare. (Shown on the reverse side)

Necessary documents

- (1) Repayment forgiveness application form (enclosed document)
- (2) Residence certificate for all members of the household (issued within the last three months, showing all members of the household)
- (3) Certificate of tax exemption for both the head of household and yourself (FY2021 or FY2022)

Deadline

August 31, 2022

Result

Around September 2022, you will be notified by letter whether or not you have been forgiven from repayment.

The Council of Social Welfare of the municipality where you live

2. Important information

- ✓ If your information has changed (address, phone number, name, death or disappearance of loan recipient), please notify us as soon as possible. Failure to notify us of any changes may make it hard to send you important information regarding forgiveness from repayment and other procedures. Make sure to notify us of any changes without delay.
- ✓ If you are not eligible for repayment forgiveness, you must carry out the repayment procedure. Around September 2022, we will send you a repayment notice by post again. Let us know which bank account you want the money withdrawn from at that time.
- ✓ The forgiveness period and tax requirements vary depending on the type of fund. This notice only covers repayment forgiveness for Temporary Loan Emergency Funds and Comprehensive Support Funds (Initial Loan). The forgiveness of Comprehensive Support Funds (Additional Loan) needs exemption from municipal tax for FY2023. Similarly, the forgiveness of Comprehensive Support Funds (Relending Loan) needs exemption from municipal tax for FY2024. (Procedures are also required then.)
